GENERAL GUIDELINES FOR THREE PEAKS AND WOODS RANCH RECREATIONAL AREAS

General Guidelines for reserving pavilions at Three Peaks Recreation Area and Woods Ranch are:

- Reservations for 2008 will be accepted beginning January 2, 2008. You may review the reservation calendars for each park on the Iron County website under Parks & Recreation. Park ordinances are on the website for your review prior to making your reservation.
- Effective January 1, 2008, Iron County Parks & Recreation will charge a fee for the use of the pavilions at Three Peaks and Woods Ranch. The fees are as follows:
 - Group up to 100 people will be \$25.00 per reservation
 - Group over 100 people will be \$50.00 per reservation
- A reservation request form must be filled out and presented with applicable fees to Iron County Parks & Recreation Office, 88 E. Fiddlers Canyon Rd, Suite F, Cedar City, UT., between the hours of 8:00 a.m. to 4:00 p.m., Monday through Friday. Reservations will be confirmed upon receipt of payment.
- Forms may be printed from Iron County website (Parks & Recreation) or they may be picked up the Iron County Parks and Recreation Office or the Iron County Visitors Center, 581 N. Main St., Cedar City, UT.
- Reservations and payment of fees must be made at the Iron County Parks & Recreation Office, 88 E. Fiddlers Canyon Rd., Suite F, Cedar City, UT., between the hours of 8:00 a.m. and 4:00 p.m., Monday through Friday.
- The reservation season for Woods Ranch is May 1, 2008 through October 31, 2008. Should you have an activity other than a picnic or small gathering prior to or after the season, please notify the director so he can advise you on the status of the park.
- Reservations for Three Peaks are on a year-round basis.
- No reservation request forms are accepted for other than the current year.
