- () June 16 - 23: Current to within three (3) days of the date of filing. Primary Election Candidates. Unopposed local school board candidates do not need to file this report.
- () July 30: Final Statements are due from candidates who were **eliminated** in the Primary Election.
- () October 20 - Oct 27 Reports are due from **all candidates** who will appear on the General Election ballot. This should include all receipts and disbursements from the date of the last report filed to current within three (3) days of the date of this filing.
- () January 11, 2021: Final report filed by **all General Election candidates** or their campaign committee. The final statements shall include all contributions and disbursements through December 31, 2020.
