

FINANCIAL CAMPAIGN STATEMENTS TO BE FILED WITH THE IRON COUNTY CLERK
Please check the appropriate report being filed:

- () April 1, 2022 Reports are due from all candidates who are going to County Convention. Once you declare candidacy, receive contribution, or spend money on campaigning you must begin reporting finances.
- () June 21, 2022: Current to within three (3) days of the date of filing. Primary Election Candidates. Unopposed local school board candidates do not need to file this report.
- () July 28, 2022: Final Statements are due from candidates who were **eliminated** in the Primary Election.
- () November 1, 2022: Reports are due from **all candidates** who will appear on the General Election ballot. This should include all receipts and disbursements from the date of the last report filed to current within three (3) days of the date of this filing.
- () December 8, 2028: Final report filed by **all General Election candidates** or their campaign committee.

Financial reports must be physically received by the election office no later than 5:00 p.m, or received electronically by 12:00 am on the day of the deadline. Please submitted to sbess@ironcounty.net
