( ) November 1, 2022: Reports are due from **all candidates** who will appear on the General Election ballot. This should include all receipts and disbursements from the date of the last report filed to current within three (3) days of the date of this filing.

December 8, 2022: Final report filed by **all General Election candidates** or their campaign committee.
