For convenience, you can pay by credit/debit card (**Visa, MasterCard and Discover**), by calling **INSTANT PAYMENTS at 435-261-7571** or go to www.ironcounty.net and use the **Justice Court drop down**, then select **ONLINE PAYMENTS** (a 2.5% merchant fee will be assessed to all fines paid by credit/debit card).

If you are cited with a charge that requires a Mandatory Appearance before the Court, please visit our website, www.ironcounty.net, select the **JUSTICE COURT** Department page. Under **ARRAIGNMENTS**, you will find forms necessary to fill out prior to your hearing. Additionally, there is a drop down for **ENTRY OF PLEA** and forms associated. Any questions can be directed to the Court by selecting the button "MAKE A REQUEST TO COURT."

ARRAIGNMENT includes the formal reading of the complaint and the explanation of the rights of the defendant as a person accused of a crime and a formal entering of a plea. **It does NOT include trial of the case to decide innocence or guilt.** It is necessary that the bail be posted to forestall prosecution on the charge of "Failure to Appear".

REQUIREMENTS FOR TRAFFIC SCHOOL/PLEA IN ABEYANCE: Traffic school only applies to traffic citations. It is **NOT** in lieu of either points against your record, fine for the citation **OR** traffic school fees. Traffic school is only available for moving violations, including speeding 1-25 MPH over the posted speed limit. **If you are charged with 26 MPH or more over the posted limit, OR speed in excess of 100 mph, you are NOT ELIGIBLE for traffic school.** All fees made payable to the Iron County Justice Court, not including the \$45.00 Online Course Fee.

***TOTAL fees for Online Traffic School are as follows:**

- (\$) Fine Amount of Violation (determined by the Utah State Bail Schedule)
- \$25.00 Iron County Administration Plea in Abeyance Fee
- \$45.00 Online Traffic School Course Fee (payable online ONLY to utahroadsafety.com)
- \$50.00 SUU In-Person Traffic School (payable to SUU Police Department)
