While some amenities are provided on site, it is the sole responsibility of the below signed parties to provide their own cleaning and hand-washing supplies, drinking water, power source, extra tables, seating, play equipment, etc.**

Three Peaks is a public park maintained by Iron County for the benefit of Iron County residents and their friends. In as much as this park is maintained by County funds, and whereas it is open to the general public for use, after appropriate reservations made and fees paid, certain **REGULATIONS AND RULES MUST BE ADHERED TO** for the benefit of the entire public and are as follows:

- **USE OF FIREARMS OR FIREWORKS IN COUNTY PARKS IS STRICTLY PROHIBITED AND SUBJECT TO PROSECUTION.**
- **NO SMOKING & VAPING!**
- No sale of beverages, goods, foods or other business or commercial transactions shall occur on the park premises without prior approval by Iron County Commissioners.
- Consumption of alcohol in county parks require a permit from Iron County Parks & Recreation. Alcohol must be contained and not in open reach areas. All Utah liquor laws and regulations must be observed. (See reverse for information on obtaining the Alcohol Consumption Permit Form)
- Fires are only permitted in designated fire pits or fire places. Fires must be doused before leaving the area! **FIRE RESTRICTIONS MAY BE IN EFFECT AND MUST BE FOLLOWED!**
- Trees may not be cut for firewood. Bring your own or pick up dead wood. **-NO PALLET BURNING ALLOWED-**
- Camping is limited to 14 days within a 30-day period. Camping is not permitted in or around the Bulloch Pavilion area. Camping **ONLY** permitted in the 17 designated campground spots and Group Campsite at Three Peaks Recreation Area. The 17 sites are first-come-first-serve at \$15.00 per night and the **GROUP SITE NEEDS TO BE RESERVED.**
- **LEAVE NO TRACE!** All trash must be carried out or deposited in the containers provided. Not buried! Please sweep out pavilions.
- Any destruction of public property or littering is a **CRIMINAL OFFENSE** punishable by fine and/or incarceration. Please report vandalism or any criminal acts to the Iron County Sheriff's Office at (435)867-7550
- **IRON COUNTY SHALL NOT BE HELD RESPONSIBLE FOR ANY DAMAGES TO PERSONAL PROPERTY BROUGHT TO THREE PEAKS RECREATION AREA. ALL PERSONAL PROPERTY IS REQUIRED TO BE REMOVED UPON COMPLETION OF THE USE OF THE PARK.**
- Please have a copy of your approved reservation with you on site.
- Please respect other groups enjoying the park.
- **PLEASE DO NOT FEED OR DISTURB WILDLIFE!**

I, the undersigned applicant under penalties or perjury, declare that I have examined and completed the above application, and to the best of my knowledge and belief, said application is a true, correct, and complete assessment of the intended use of the park. I agree to the rules and regulations. I also agree to indemnify, defend, and hold harmless Iron County and/or its agencies and representatives against and from any and all demands, claims, liabilities of every nature whatsoever, including but not limited to, damages to property, or injuries or death of persons arising directly or indirectly from the use and occupancy of the recreation area.

## RESERVATION GUIDELINES FOR THE THREE PEAKS FACILITY

- Iron County Three Peaks Campground amenities are as follows: ***(Pavilion and Group Campsite require advanced reservation)***
  - The Bulloch Pavilion which has 10 picnic tables, a large charcoal grill, fire pit, and playground.
  - The Group Campsite and Pavilion which includes 6 picnic tables, a large charcoal grill, a fire pit, and 1.25 acres of camping space for tents and RV's. (NO HOOK-UPS)
  - 17 first-come-first-serve campsites which include covered picnic tables, fire pits w/grates, and room for several vehicles, tents, and/or a RV in most sites. (NO HOOK-UPS)
  - Two double vault toilets and two single vault toilets.
  - Trash cans
  - Seasonal water (NO RV HOO-UPS)
  - No Electricity
- As of January 1, 2024, Iron County Parks & Recreation charges a NON-REFUNDABLE fee for use of the Bulloch Pavilion and Group Campsite.

The fees are as follows:

  - Groups up to 100 people will be \$35.00 per day, per reservation.
  - Groups of 101-200 people will be \$60.00 per day, per reservation.
  - Groups over 200 needs prior approval.
  - Schools K-12 Free
  - Overnight camping fee is \$15.00 per night on a FIRST-COME-FIRST-SERVED basis in only the 17 designated spots.
- The reservation season for the Three Peaks Campground is on a Year-round basis.
- ***No reservation requests are accepted for other than the current year.***
- **NO RESERVATION APPLICATION WILL BE ACCEPTED UNTIL THE FIRST WORKING DAY OF THE CALENDAR YEAR.** You may review the reservation calendar for Three Peaks on the Iron County website at [www.ironcounty.net](http://www.ironcounty.net) under "Parks & Recreation" in the Departments section. **Park ordinance are on the website for your review prior to making your reservation.**
- A reservation request form **MUST** be filled out and presented with applicable fees, in the form of cash, check, or credit card to the Iron County Parks & Recreation Office at 581 N Main St., Cedar City, between the hours of 8:30 am to 5:00 pm; Monday through Friday. Reservations will only be confirmed by the reservation coordinator and upon receipt of payment.
- A 2 week temporary hold may be placed to save a requested date. If not confirmed within this period, Iron County reserves the right to offer the date(s) to another party.
- **Consumption of alcohol in county parks requires a permit from the Iron County Outdoor Recreation Department.**
- The Reservation Application and Alcohol Use Permit Forms may be picked up at the Cedar City Visitor Center at 581 N Main St., Cedar City, or on the county website at [www.ironcounty.net](http://www.ironcounty.net). Under the "Departments" section, select "Parks & Recreation", then "Reserve a Pavilion".
- **Special Events are required to obtain a permit and supply additional documentation such as liability insurance, Medical and Law Enforcement notifications and are also subject to a \$500.00 fee. Please contact the Parks & Recreation Director well in advance to start your permit process.**
