RESERVATION GUIDELINES FOR THE WOOD RANCH FACILITY

- Wood Ranch amenities are as follows: (The pavilions require advance reservation)
 - One Large Pavilion with 10 picnic tables, a large charcoal grill, a fire pit, fireplace, Volleyball court, Horseshoe pits, and a playground.
 - One Small Pavilion with 6 picnic tables, a large charcoal grill, a fire pit, and a fireplace.
 - Kid's pond where children 12 and under may fish for free. (Must be accompanied by an Adult with a valid Utah Fishing License)
 - Trash cans
 - Season Water
 - Electricity
 - Two double vault toilets
 - Large grassy meadow
 - Several picnic tables and charcoal grills throughout area that are on a first-come-first-served basis.
 - Emergency Satellite Phone
- As of January 1, 2024, Iron County Parks & Recreation charges a NON-REFUNDABLE fee for group use of the pavilions at Wood Ranch.

The fees are as follows: - Groups up to 100 people will be \$35.00 per day, per reservation.

- Groups of 101-200 people will be \$60.00 per day, per reservation.
- Groups over 200 needs prior approval.
- Schools K-12 Free
- The reservation season for the Wood Ranch park is June 1st (weather permitting) through September 30th. Should you have a picnic or small gathering prior to or after the season, please notify the director so she can advise you on the status of the park. Should you reserve the park at the end of the season, take in consideration the winterization schedule.
- No reservation requests are accepted for other than the current year.
- NO RESERVATION APPLICATION WILL BE ACCEPTED UNTIL THE <u>FIRST WORKING DAY</u> OF THE CALENDAR YEAR. You may review the reservation calendar for Wood Ranch on the Iron County website at www.ironcounty.net under "Parks & Recreation" in the Departments section. Park ordinance are on the website for your review prior to making your reservation.
- A reservation request form MUST be filled out and presented with applicable fees, in the form of cash, check, or credit card
 to the Iron County Parks & Recreation Office at 581 N Main St., Cedar City, between the hours of 8:30 am to 5:00 pm;
 Monday through Friday. Reservations will only be confirmed by the reservation coordinator and upon receipt of payment.
- A 2 week temporary hold may be placed to save a requested date. If not confirmed within this period, Iron County reserves the right to offer the date(s) to another party.
- Consumption of alcohol in county parks requires a permit from the Iron County Outdoor Recreation Department.
- The Reservation Application and Alcohol Use Permit Forms may be picked up at the Cedar City Visitor Center at 581 N Main St., Cedar City, or on the county website at www.ironcounty.net. Under the "Departments" section, select "Parks & Recreation", then "Reserve a Pavilion".
- Special Events are required to obtain a permit and supply additional documentation such as liability insurance, Medical
 and Law Enforcement notifications and are also subject to a \$500.00 fee. Please contact the Parks & Recreation Director
 well in advance to start your permit process.
